Help! We Need Child Care -Alison's Story, Part 1

Alison and Chris began their child care search when Alison was well into her first pregnancy. As a UVM employee, Alison's first choice was UVM's child care center. She quickly found that there were no spots available. Upon the recommendations of friends, she tried a couple of Burlington centers – again no spots. Searching on-line was just as frustrating. Finally, she found Child Care Resource on the UVM website. Just before Ezra was born, Alison and Chris found family child care provider Donna Leicht in Burlington. Initially, they weren't interested in family child care they thought that centers were better for kids – but they felt desperate and family child care was their only option. So they decided to try it.



fragile and having to leave them with someone else was heartbreaking. It was more difficult to work and be a Mom than I thought – all of a sudden the new baby had become the most important thing in the world. Donna's is close to where I work so I could be with the baby to nurse once per day on my lunch hour. That made me feel better.

Alison and Chris believe in giving children room to develop and discover who they are. They want their children to engage in a lot of creative play, be physically active and mentally engaged, and to discover the world around them. They want them to build social confidence by interacting with other children and adults. They found all of this at Donna's.

"It's amazing how many things they learn and what they come home with. Lately they've been interested in birds – looking for birds, observing birds, listening for birds. At Donna's, they are learning how to observe, how to be good scientists."

When Aria was born just 18 months later, Donna did not have a spot for her. It would be close to a year before a spot would be available. So, Alison enrolled Aria at a nearby





family child care home. When Aria was only 6 months old, the provider told Alison that she could no longer care for Aria and Alison had two weeks to make new arrangements. After hearing this news, Alison desperately needed to talk to someone about her feelings and her child care needs so she called CCR again. opened center willing to do a shortterm contract. The family now had the bridge in care needed until Aria could start at Donna's.

Finding care for two children under the age of two is one of the hardest child care challenges. Many of the families we help have similar challenges and fewer supports and resources than Alison and Chris did. Alison appreciates that Donna is able to provide child care to children from a wide variety of backgrounds. Child Care Resource helps some of these families receive state assistance to pay the tuition that Donna charges. For families who are homeless and in transition, putting the two together – finding child care and getting help to pay for it – is essential for re-establishing safety and security. Alison was nursing Ezra at Donna's when she first watched Beth - Child Care Resource's licensed consulting teacher - working with the children and Donna. Beth visits Donna weekly as part of Child Care Resource's Family Child Care Prekindergarten Partnership. Finally, Ezra, now age 3, has become officially involved in the program but Alison feels that he has benefited since he was a baby.
