## Families Found Child Care by Calling CCR in FY17

In FY17, Child Care Resource helped 888 families search for child care for 1088 children.

**97% of families said they would use the service again.**

"What a GREAT resource - thank GOD I learned about you from a Seven Days article. Never knew! Working moms need more HELP in finding care!!! Especially for infant spots. It's the hardest times for moms and babies!"

"This service is amazing. It saved me much time calling all the places online that did not have openings, which I wouldn't have known unless I called! **67% of families reported finding care after their first search. Other searches were more difficult.**

"It has been very difficult trying to find child care for an infant (even though I started looking 6 months in advance). There are minimal openings in Chittenden County and I couldn't find any in Franklin County (after calling over 40 in-home and day care centers)."

"I know we're not alone in our struggle to find quality and affordable care, but the fact that this whole process is a challenge in the first place feels so wrong. We can barely afford to send our daughter to our current center, and yet the teachers who work there make far less than we do. I very much appreciate the services you provide, but clearly there are some larger issues at hand here, making this process a huge challenge."

"Navigating the childcare system is a huge challenge. As a new Vermonter, there is definitely a learning curve in regards to



Act 166, availability of subsidies and the wide variety of care in the area. I was so relieved to have been referred to Child Care Resource, which dulled the headache of finding child care immensely. Thank you so much!"





## Families Got Help Paying for Child Care

In FY17, Child Care Resource processed 2,702 applications for child care financial assistance from low-income families in Chittenden County.

- **68% of applicants needed child care because they were employed or in a training/education program.**
- **23% of applicants needed child care due to family stress and risk factors that had lead to or could lead to child abuse or neglect.**
- **1,510 families had access to child care financial assistance each month. Families that contact us are under much financial pressure and we do our best to make child care work for them.**

**97% of families responding to our customer satisfaction survey said that our case managers are friendly, answer all of their questions, and give them all the information they needed.**

# The Child Care Workforce had Year-Round Affordable Professional Development



**100% of participants say that they gained new knowledge and will apply this knowledge in their program.**

**1008 participants completed 12,933 hours of training.**

# Children had Nutritious Meals in Child Care

In FY17, Child Care Resource supported 447,811 meals for children in:

- Family child care programs
- Child care centers
- After-school programs
- Teen centers
- Homeless shelters

**2,110 children  
were enrolled and  
65% lived in low  
income households.**



Staff at participating programs say that because of the meals served, children:

- Are more likely to have enough nutritious food available to them
- Are more likely to try new foods
- Have a healthier diet

“Generally speaking, we had children who would bring in donuts, sugary foods, unhealthy processed foods (gearing them towards an unhealthy future). Now they have the opportunity to at least eat 3 healthy meals for 5 days of the week.”

“When you consider the fact that our children are growing so much during these first crucial years – it makes me so grateful for the food program and all the support it has given our children”
